**2011 Oceania ISF Certification Seminar** was held at Redlands, Brisbane in conjunction with the Australian Men's and Women's Open Championships. I pleased to again report that all thirteen candidates obtained certification. Additionally successful candidates Helen Strauss, Yvonne Kahler and David Shedlock have been appointed to officiate at the

ISF IX Junior Women's World Championship in South Africa in December.



The next Oceania ISF Certification Seminar is tentatively scheduled for March 2013 in New Zealand in association with the 2013 ISF Men's World Championship. Details will be finalized after regional consultation and confirmation by the ISF Director of Umpires Bob Stanton. Candidate preparation for this event is already underway in both Australia and New Zealand.

**ISF Pitching Presentation** congratulations to Softball Australia on taking the lead role in the final production of this very valuable educational tool to deliver on the Pitching Rule changes at the 2009 Congress.

The journey to get to this point began shortly after Congress with the publishing by Bob Stanton of the first issue of the ISF Pitching Points of Emphasis following peer review input from Softball New Zealand and Softball Canada. This followed by the first of the Power Point/Video presentations produced by SNZ's Director of Pitching Debbie Mygind. This presentation was made available to the ISF and shared with SA and SC. A preseason 2010 NZ nationwide presentation road-show to players, coaches and umpires proved its worth with the smooth introduction of the changes and a much improved level of compliance. SA adapted and produced a more detailed presentation for their national use. This was professionally facilitated through Leigh Evans and the offices of SA.

Following field evaluations and consultations, a minor revision was made to the ISF Pitching Points of Emphasis and reissued by Bob Stanton. The very detailed SA presentation was reviewed and adapted for ISF use and is now ready for issue for the good of the ISF.

I am personally aware of the many contributions along this journey but would like to record a very special thank you to Leigh Evans who has put many volunteer hours into supporting the ISF on this project.
