We will shortly announce our Trans Tasman exchange umpire whilst further International appointments are in progress.

The latest National Tournament Appointment, Examination and Travel/Accommodation Schedules, Issue C, will be posted to Associations and the website in the next few days. SNZ have nearly finalized travel and accommodation details. Details will be posted to Associations ASAP. Air travel ET's will be emailed to each umpire as soon received. A very impressive 27 candidates will be under examination at this seasons National Tournaments and 27 have already gained a Rules Examination mark for Level 2 qualification.

At the ISF Congress in Manila, I attended a number of sessions including the Umpires Commission as secretary, Females in Umpiring, BackSoftball the ISF's return to the Olympics campaign and the Oceania Confederation meeting. Minutes from the Umpires Commission will be available through your Association and will be distributed to the Level 7 Group by Lindsay. Further information on a new ISF recertification and upcoming ISF certification clinic programmes will be made available in due course. Whilst Margo's presentation on Females in Umpiring showed Oceania leading the way in percentage participation, special efforts will be initiated to increase female participation as part of the BackSoftball campaign. We all need to consciously support this Special Project.

A word or two of appreciation to our former Oceania UIC Margo Koskelainen, Margo moves to ISF Special Projects. Last week it was announced that I had been appointed to the vacant Oceania UIC role.
